Penalty of Hazardous Cargo Misdeclaration PRN/PRE/PRS to MCC All Destinations

Dear valued customers,

Incorrectly declared hazardous cargo adds a high risk to the safety of our vessel/crew safety both at sea and on shore. To strengthen the governance of hazardous cargo misdeclaration, please be advised that we will be levying the penalty charge of Hazardous Cargo Misdeclaration for all cargo export form North China, East China & South China to MCC all destinations (excluding Russia*), effective December 1st, 2017 (vessel proforma ETD date).

The penalty charge of Hazardous Cargo Misdeclaration is detailed in the following –

| Name | Amount (USD) | Collect Basis |
|----------------------|-------------------|---------------------------|
| Penalty | 10,000 | Per Misdeclared Container |
| Extra Operation Cost | Subject to Actual | Per Misdeclared Container |

The above penalty will be charged to the responsible customer who is identified to the violation of any of below rules:

- Booked and declared commodity as "Non-Hazardous cargo" while commodity identified is "Hazardous cargo"
- Booked and declared commodity as Hazardous cargo with incorrect IMO Class or UN No. Example: IMO declared as Class 9 but it's identified as IMO Class 5.1

关于危险品货物瞒报/误报违约金通知 华北、华东、华南地区出口至亚洲各地

尊敬的客户:

错误申报或瞒报危险品货物会对海上运输安全及合法性产生严重后果,亦有可能带来巨大的经济损失。穆勒亚洲航运一直致力于维护海上运输安全,将会进一步提高对危险品货物申报的监管,目的是要减少错误申报的情况以降低误报所带来的风险。对于华北华南华东出口到亚洲各地(*俄罗斯除外)集装箱内货物瞒报及误报的情况,我司将从 2017年 12 月 1 日(预计开船日)起收取相应的违约金,具体违约金收费标准及规定如下:

| 收费项目 | 金额 (美金) | 征收单位 |
|--------|---------------|------|
| 违约金 | 10,000 | 每误报箱 |
| 额外操作费用 | 按实际产生之操作成本及费用 | 每误报箱 |

上述违约金将针对以下情况向未有遵守规定的客户征收:

- 任何实际为危险品货物但申报为非危险品货物
- 危险品级别及 UN 号码的瞒报和误报,例如:实际為 5.1 类货物但申报为 9 类货物
