

## 关于西非部分国家的制单要求

尊敬的客户及代理：

OOCL 已经新开通西非直达航线，现将西非部分国家的提单要求汇总如下。期待您对 OOCL 一如既往的支持！

### 1. Nigeria

- FORM M number & BA Number must be displayed on BL for cargo import to Nigeria (except personal effects) and the recommended field is Cargo Description
- Full company name & detailed address of shipper and consignee must be displayed on B/L. When consignee is to order, full company name & detailed address of notify party must be displayed on B/L
- Freight Collect (ocean freight and related charges) is unacceptable [it going to be aligned with Fincon policy]

### 尼日利亚

1. 请务必提供 FORM M Number 和 BA Number（私人物品除外），并显示在货描处；
2. 请务必提供发货人和收货人的公司名称，地址，城市和国家，并显示在提单上。如果收货人是 to order，请务必提供发货人和通知方的公司名称，地址，城市和国家，并显示在提单上；
3. 不接受海运费及相关附加费在尼日利亚结算，即不接受海运费及附加费到付。

## 2. Ghana

- CTN (cargo tracking note) number, an official loading certificate number which confirmed detailed information about cargo and its movement between ports, must be displayed on B/L
- All Vehicle types must have FULL Chassis (VIN) number, Serial number, Engine Number, Year of Manufacture, Model & Make indicated on B/L
- All Transit cargo must have Transit clause “Cargo in Transit to xxx (country name) under consignee’s risk & account” in cargo description column of B/L. Consignee must be located in final destination corresponding to the Transit clause

### 加纳

1. 请务必提供货物跟踪单号，即 CTN (cargo tracking note) Number, 并显示在提单上;
2. 如果运输的货物是“车辆”，需要提供并显示如下信息在提单上：
  - 1) Chassis (VIN) number,
  - 2) Serial number,
  - 3) Engine Number,
  - 4) Year of Manufacture,
  - 5) Model & Make
3. 如果是转运货物，需要在货描处显示转运条款“Cargo in Transit to xxx (country name) under consignee’s risk & account”，并且确保提单收货人所属的国家跟转运条款中目的地国家一致。

### 3. Senegal

- CTN (cargo tracking note) number, an official loading certificate number which confirmed detailed information about cargo and its movement between ports, must be displayed on B/L

#### 塞内加尔

1. 请务必提供货物跟踪单号，即 CTN (cargo tracking note) Number, 并显示在提单上。

### 4. Cote d'Ivoire

- CTN (cargo tracking note) number, an official loading certificate number which confirmed detailed information about cargo and its movement between ports, must be displayed on B/L

#### 科特迪瓦

1. 请务必提供货物跟踪单号，即 CTN (cargo tracking note) Number, 并显示在提单上。
