IMO 2020 Fuel Legislation

2020 March | Bunker Adjustment Factor (BAF) Surcharge Outbound Far East Asia

With reference to our announcement on 21 January 2020, the substantial cost increases to 0.5% Sulphur fuel oil (VLSFO) per metric ton have triggered a monthly review of the Bunker Adjustment Factor (BAF) Surcharges. Based on Bunkerworld's fuel price index for VLSFO, the average fuel price calculated in key bunkering ports from 26 December 2019 to 25 January 2020 was 630,99 USD / mt. In comparison to the previous measuring period (26 August 2019 – 25 November 2019), the difference represents an increase of 93 USD/mt.

Accordingly, effective 1 March 2020, Hamburg Süd will review its Bunker Adjustment Factor (BAF) Surcharges as follows:
