In consideration of the delivery in due course of the goods specified below to the consignees thereof without collection of a deposit, we, the undersigned insurers, hereby undertake to pay to the shipowners or to the Average Adjusters, Richards Hogg Lindley, on behalf of the various parties to the adventure as their interests may appear, any contribution to General Average and/or Salvage and/or Special Charges which may hereafter be ascertained to be properly and legally due in respect of the said goods. "EVER GIVEN" - GENERAL AVERAGE DECLARATION - SUEZ CANAL GROUNDING

On 23 March 2021, whilst the *Ever Given* ("**The Vessel**") was on passage from Malaysia to Rotterdam, the Vessel grounded in the Suez Canal, Egypt. Further to a six-day salvage operation engaging tugs and dredgers the Vessel was refloated on 29 March 2021. The above circumstances give rise to General Average and the vessel owners declared General Average on Apr 1, 2021 and have appointed Richards Hogg Lindley as the General Average Adjuster, to collect the necessary GA security.
