 2. S/I Cut: Shipper / booking agents shall provide S/I within deadline as standard requirement.
 3. Equipment usage is calculated from the date of empty picking up till "Proforma Departure" announced in this notice. Please visit LINDO website to get more detailed tariff.
 4. Cy-in time is usually 5days prior to Pro-forma ETD. It is subject to change without prior notice based on port authority's arrangement. Please ensure to double check on terminal website before laden gate-in to avoid unnecessary loss.
 5. It will be subject to carrier's decision to load onboard or not and stow under option for the later coming container (deliver either Laden or Dook Receipt to the terminal or customs releasing after CY-cut time).
 6. Shipper/booking agent shall be responsible for all extra penalty, restow or tranship costs incurred due to wrong declaration on cy-in code or weight (both cargo and gross weight) information. Please visit terminal website to check whether information is correctly declared or not.

 4.进箱开始一般为预计离港日前5天。根据实际情况, 港区可能随时更改进箱时间。为避免损失, 请务必参考港区官方网站安排进箱。
 5.如货柜或场站收据交付至现场时间或海关放行时间晚于截关时间, 我司将视实际情况决定放行与否及装船位置。
 6.货主/订舱代理须承担因装箱单上的进港代码和重量(包括货重和总重)的填制或预录错误而造成的额外罚金、翻舱、中转费用。可访问港区官方网站查询填制及预录正确与否。
