 2. S/I Cut: Shipper / booking agents shall provide S/I within deadline as standard requirement.
 3. Equipment usage is calculated from the date of empty picking up till "Proforma Departure" announced in this notice. Please visit LINDO website to get more detailed tariff.
 4. Cy-in time is usually 5days prior to Pro-forma ETD. It is subject to change without prior notice based on port authority's arrangement. Please ensure to double check on terminal website before laden gate-in to avoid unnecessary loss.
 5. It will be subject to carrier's decision to load onboard or not and stow under option for the later coming container (Laden gate-in or Customs releasing after closing time).
 6. Please ensure to declare correct cy-in code on both paper CLP and E-CLP as per our latest Cy-in code list (except Special Routing or Optional Space containers), which is updated to you by email or published on LINDO website.
 7. Shipper/booking agent shall be responsible for all extra penalty, restow or tranship costs incurred due to wrong declaration on cy-in code or weight (both cargo and gross weight) information. Please visit terminal website to check whether information is correctly declared or not.

注意事项:

 2.提单截止: 货主订舱代理须于截止时间前按规定发送提单样本。

 4.进箱开始一般为预计离港日前5天。根据实际进港情况, 港区可能随时更改进箱时间。为避免损失, 请务必参考港区官方网站安排进箱。
 5.如货柜交付至现场时间或海关放行时间晚于截关时间, 我司将视实际情况决定放行与否及装船位置。
